1. OPENING OF MEETING

The Chair acknowledged that 2022 was the first year that REINZ was holding a hybrid AGM, in person and online and noted that half the attendees were attending online.

The Chair declared the AGM of the Real Estate Institute of New Zealand (REINZ) open and quorate at 10.15am and extended a warm welcome to everyone attending.

The Chair acknowledged the attendance of the REINZ Board, Life and Fellow Members in attendance, and the REINZ team.

The Chair noted that:

- (a) the meeting was being recorded;
- (b) notice of the meeting and its order of business had been circulated and distributed to all members;
- (c) any voting during the meeting would be held by way of a poll. For those attending in person, this would be by way of voting slips. For those online, a poll would appear on their screen at the appropriate time. Rule 3.5 of REINZ Rules sets out the rules for eligibility to vote. If in person attendees were not eligible to vote, then no action was required. For those online, the Chair explained that they would need to select "not applicable" when the poll appeared on their screen as otherwise it would prevent the online poll from closing.

The Chair then discussed the procedure in respect of any questions at the meeting. For those attending in person, they must raise their hand. For those online, there is a Q&A function on their screen to ask questions (noting not to use the chat function).

2. APOLOGIES

Apologies were noted. Refer to Appendix Two for the full list.

3. OBITUARIES

AGM attendees were asked to stand and observe a minute's silence for members and friends who passed away during the year.

Refer to Appendix Three for the full list of obituaries as read by the Chair.

4. NOTE MINUTES OF THE 2022 AGM

The Chair noted that the minutes of the 2021 REINZ AGM held on 24 November 2021 had been APPROVED by the REINZ Board. The minutes had then been made available on the website in advance of the meeting and members were invited to read those minutes. No concerns were raised before the AGM or at the meeting. The minutes were recorded as a true and correct record of that meeting, with no matters arising.

5. RECEIVE AND CONSIDER THE REPORT OF THE CHAIR OF REINZ

The Chair spoke to her report as published in the 2021/2022 REINZ Annual Report and commended the content of the Annual Report.

The Chair then spoke about the four pillars of REINZ's strategy, which included building a future ready profession, improving the skills and knowledge of our members, augmenting our role as provider of digital products and data insights, and delivering operational excellence.

The Chair extended a vote of thanks to REINZ Chief Executive, Jen Baird, and gave her best wishes to the REINZ team, noting their commitment to focusing on the industry and its growth and success. The Chair also thanked the Industry Leaders, Ambassadors, as well as her fellow board members.

The Chair received no questions from the floor regarding the Chairperson's report. The Chair's report was received.

Moved: Angela Bull. Seconded: Jo Clifford. Carried: Unanimously

Miriam Dean KC then acknowledged the Chair's support and collegiality on the board over her tenure.

Jen Baird, Chief Executive, also acknowledged the Chair's pragmatic and calm approach in her leadership and appreciated the support she had shown her time as the CEO of REINZ.

The Chair was then presented with a token of thanks by Miriam Dean KC on behalf of REINZ.

6. RECEIVE AND CONSIDER THE REPORT OF THE CEO OF REINZ

Jen Baird, Chief Executive, expressed her thanks to members, the Board and the REINZ team, and highlighted key points of the CEO report as documented in the 2021/2022 Annual Report, including also discussing REINZ's strategy.

The CEO's report was received with no questions from the floor.

Moved: Treena Drinnan: Helen O'Sullivan: Unanimously.

7. RECEIVE AND CONSIDER THE ANNUAL ACCOUNTS AND AUDITOR'S REPORT

The CFO, Rowan Dixon addressed the AGM and spoke to the Annual Accounts for the year ended 30 June 2022, highlighting the key points of the CFO report as documented in the 2021/2022 Annual Report and confirming that REINZ had had another successful year from a financial perspective.

The Chair opened for questions and received one question regarding whether the Annual Accounts record the gender balance of members. Rowan Dixon confirmed that presently they do not. Inclusion could be considered in future years.

The FY2021 Annual Accounts and Auditor's Report were received.

Moved: Helen O'Sullivan. Seconded: Angela Bull. Carried: Unanimously.

8. APPROVAL OF LIFE MEMBERS (as per Rule 3.3(e)(iv)

The Chair addressed the attendees and provided an overview of the voting process for Life Members both in person and online. The Chair noted that voting would be conducted per REINZ Rules and the published Life Member Voting process. Bridget confirmed that three nominations were received for:

- (1) (The late) John ABBOTT, FREINZ nominated by Bryan Thomson, Life Member, who also read the citation;
- (2) Peter NEYLON, Retired FREINZ nominated by Peter Whalan, AREINZ. Citation read by Shane O'Brien; and
- (3) Carey SMITH, AREINZ nominated by Treena Drinnan, Regional Director, REINZ, who also read the citation.

Members then voted on each of the nominees following the citations read by the above persons. After the results had been collated and checked, the Chair announced that all three nominees were approved as Life Members.

The Chair presented the new Life Members with commemorative certificates and invited the new Life Members to say a few words.

9. DIRECTORS' FEES

Melisa Beight, REINZ's General Counsel, explained the proposed increase in directors' fees, noting that directors' fees had not been increased since November 2017. The proposed adjustment was in line with the independent Institute of Directors salary survey report for 2021/2022. Details of the proposed increase are in Appendix Four.

The Chair then opened the voting. After the results were collated and checked, the proposed adjustment was confirmed as having been approved.

10. CHANGES TO REINZ RULES

The Chair noted the changes to REINZ Rules and handed the meeting over to REINZ's General Counsel, who explained the changes to the Rules that members had voted on. See Appendix Five for more detail. The General Counsel explained that the updated REINZ Rules would now be filed with the Incorporated Societies Register, at which time the updated REINZ Rules would come into effect.

The General Counsel received no questions from the floor regarding the REINZ Rule changes.

11. THE CODES OF PRACTICE

The Chair then noted the changes to the Codes of Practice. The General Counsel advised the Codes of Practice have been reviewed and updated since the last AGM. Refer to Appendix Six for details.

The General Counsel received no questions from the floor regarding the amendments to the Codes of Practice.

12. DECLARATION OF APPOINTMENT OR ELECTION OF DIRECTORS AND CHAIR

Nominations for Regional Directors were sought for Region 2 (Waikato, Bay of Plenty & Gisborne)

Region 4 (Nelson, Marlborough, Canterbury and Westland).

The incumbent directors' nominations were uncontested, and the directors had made themselves available for reelection. Accordingly, in accordance with the REINZ Rules, they would serve for

another term. Congratulations to Neville Falconer and Shane O'Brien.

The Chair acknowledged the importance of continuity on the Board and thanked both directors for making themselves available again. The Chair thanked all directors for their continued hard work and support.

The Chair invited Miriam Dean KC to discuss the independent director and chairperson selection process.

Miriam Dean KC noted that Bridget Coates and Angela Bull's terms as independent directors were to end at the AGM. Angela had made herself available for re-appointment, whilst Bridget was retiring at the AGM. The Appointments Panel, chaired by Peter Thompson, along with panel members Miriam Dean KC, Andy Evans, Mark Sandelin and Vanessa Golightly had re-appointed Angela for another two-year term. Angela was congratulated.

The Appointments Panel, with the assistance of recruitment company, Hobson Levy, had also appointed Kevin Jenkins as REINZ's new independent director and likely chair, subject to confirmation at the board meeting to be held that afternoon.

Kevin Jenkins was congratulated. He then spoke to those attending the AGM and acknowledged it was a privilege to be appointed to serve REINZ and the industry.

13. NEW FELLOWS ANNOUNCED

The Chair announced the new Fellows for 2022, noting that all had been unanimously approved by the board, namely:

- (1) Yvonne BOX;
- (2) Gladys GLAVISH;
- (3) Alfred (Wayne) RAWSON; and
- (4) Andrew (Andy) STEWART.

The Chair presented each new Fellow with a commemorative certificate.

14. GENERAL BUSINESS

The Chair opened the floor for any general business items in respect of the AGM, noting that no motions had been received ahead of the AGM.

- REINZ was asked about advocacy efforts in respect of interest deductibility. The CEO responded that
 supporting the private sector in solving the housing sector was a top priority and that interest deductibility
 was part of the discussions REINZ was having with Government and other parties.
- The Board was asked about Realestate.co.nz and the payment of dividends versus re-investing funds back into Realestate.co.nz. The Chair noted that this was more a discussion for Realestate.co.nz's AGM and the boards of the respective organisations would consider the dividend policy.

The Chair thanked everyone for attending the AGM.

There being no further business the meeting was closed.

APPENDIX FOUR - DIRECTORS' FEES

DIRECTORS' REMUNERATION

The last increase in directors' fees was approved at the November 2017 AGM.

The following adjustments have been proposed. Note the figures below are per annum:

Once approved, adjusted fees take effect from the date of the AGM, with an annual CPI adjustment applied annually thereafter.

A simple majority of eligible voters is required to approve the increase: refer Rule 7.7(a) REINZ Rules.

APPENDIX FIVE - CHANGES TO REINZ RULES

- 1. A new REINZ affiliated individual salesperson and REINZ affiliated individual property manager status was created.
- 2. The second change codified the requirement for residential property management agency members to operate a trust account for client funds, which is audited, or has an independent review annually, with a grace period until 1 June 2023 before REINZ will start conducting annual audits for compliance.
- 3. AREINZ designation. There are some minor clarifications to make it clear that a successful application is required before a member can use the 'AREINZ' designation behind their name.
- 4. REINZ sector groups the maximum number of sector group representatives is increased from 6 to 8.

APPENDIX SIX - CODES OF PRACTICE

- 1. There is a new Code of Practice for REINZ Affiliated Individual Property Managers and for REINZ Affiliated Individual Salespersons.
- 2. There are some minor updates to the REINZ Code of Practice for Residential Property Management.
- 3. There are some minor updates to the REINZ Sector Groups Role Description & Code of Practice, including increasing the maximum number of sector group representatives to 8.
- 4. The REINZ Ambassadors Role description & Code of Practice has some very minor word changes.
