### **Fellowship Nomination Criteria:**

1. Has been an Associate member for a minimum of 10 years.
2. Has served on either the District Committee, District Forum/REINZ Ambassador, Special Interest Group or Sector Group, or made a major contribution to the real estate industry locally or nationally.
3. Has been and remains an active supporter of the Institute and its events.
4. Has made a contribution to the community as a result of real estate experience.
5. Remains a member of REINZ (or applies for and is granted the “Retired” designation).

### **Nomination Process:**

- Can be initiated by any Fellow or Associate Member (from any region) to a local REINZ Ambassador or Sector Group Representative.
- Nomination proposed by REINZ Ambassador or Sector Group Representative by written citation to Regional Director with support from five other AREINZ or FREINZ members from the region (on forms provided by REINZ)
- Regional Director considers and, if in agreement, forwards the recommendation to the CEO with his or her support.
- CEO validates all supporting data, determines that nominee is willing to accept nomination and forwards to Board for consideration and approval.
- No fee is payable.
